RESOLUTION NO. <u>2017-1212</u>

A RESOLUTION OF THE STEWART COUNTY BOARD OF COMMISSIONERS PROVIDING FOR A BUDGET FOR THE FISCAL YEAR BEGINNING JANUARY 1, 2018 AND REPEALING ALL RESOLUTIONS IN CONFLICT WITH THIS RESOLUTION.

WHEREAS, under O.C.G.A. § 36-81-3, the governing authority of Stewart County, the Stewart County Board of Commissioners, must approve an annual balanced budget for the general fund, each special revenue fund, and each debt service fund in use by the local government; and

WHEREAS, after careful consideration and after a public hearing, the Stewart County Board of Commissioners intends to adopt a budget for the fiscal year beginning January 1, 2018; and

WHEREAS, the Board of Commissioners has complied with O.C.G.A. § 36-81-5, which sets out the requirements established by the General Assembly for the State of Georgia for the adoption of budgets by local governments; and

WHEREAS, the Board of Commissioners intends to operate the County as efficiently as possible and has drafted a budget intended to provide necessary services in a cost-efficient manner; and

WHEREAS, under O.C.G.A. § 36-81-4, where a local government has not appointed a budget officer, the governing authority shall perform all duties of the budget officer as set forth in O.C.G.A. § 36-81-5; and

WHEREAS, under O.C.G.A. § 36-81-2, the "legal level of control is "the lowest level of budgetary detail at which a local government's management or budget officer may not reassign resources without approval of the governing authority", which legal level of control shall be, "at a minimum, expenditures for each department for each fund for which a budget is required"; and

WHEREAS, under O.C.G.A. § 36-81-3, the governing authority of a local government may, by adoption of an ordinance or resolution, amend the legal level of control to establish a more detailed level of budgetary control at any time during the budget period; and

WHEREAS, under O.C.G.A. § 36-81-5, the County may establish a legal level of control at a more detailed level of budgetary control than the minimum required legal level of control; and

WHEREAS, under Article I, Section 16 of the Stewart County Code of Ordinances (1995 Georgia House Bill 1902, approved by the Governor and made effective April 4, 1996), "No expenditures of county funds shall be made except in accordance with the county budget, or amendments thereto, adopted by the board of commissioners. The chairperson of the board of commissioners shall enforce compliance with this provision by all departments of county government and to this end shall institute a system of allotments of all moneys appropriated and budgeted"; and

NOW, THEREFORE, BE IT RESOLVED by the Stewart County Board of Commissioners, and be it ordained by authority of the same, effective immediately upon passage, as follows:

- 1) The annual budget for Stewart County, Georgia for the period beginning January 1, 2018 and ending December 31, 2018, in the total amount of \$4,045,234.61, with expenditures as set forth in a copy of the budget attached to this Resolution as "Exhibit A", is adopted.
- 2) The Stewart County Board of Commissioners explicitly chooses to not appoint a budget officer and chooses to retain full control over the 2018 budget, retaining sole authority to approve expenditures of funds that are not in accordance with the annual budget.
- 3) The legal level of control for the 2018 budget approved in this Resolution shall be at the line-item level detailed in the budget, attached as "Exhibit A", and, therefore, no transfers of appropriated amounts may be made without consultation and approval by the Stewart County Board of Commissioners.
- 4) All resolutions and parts of resolutions in conflict with this Resolution are hereby repealed.

A RESOLUTION OF THE STEWART COUNTY BOARD OF COMMISSIONERS TO APPOINT A COUNTY LEGISLATIVE COORDINATOR (CLC)

WHEREAS, legislative decisions made by the Georgia General Assembly increasingly impact county governments; and

WHEREAS, the Association of County Commissioners of Georgia ("ACCG") monitors and reports on legislative proposals on a regular basis during and after each legislative session; and

WHEREAS, ACCG regularly seeks input and comment from county officials and staff in assessing the impact of legislative proposals and in developing responses to such proposals; and

WHEREAS, to ensure an effective and accurate response, there must be a process whereby reports from ACCG and requests from ACCG for information or analysis of legislative proposals are directed to the most appropriate county officials or staff for a response.

NOW, THEREFORE, BE IT RESOLVED to most effectively respond to legislative proposals affecting counties, there shall be one county official or staff person designated by the board of commissioners to serve as the County Legislative Coordinator (CLC) for Stewart County.

BE IT FURTHER RESOLVED that the CLC for Stewart County shall have the following:

- 1. Access to all department heads and county officials to obtain information and data.
- 2. Access to the members of the board of commissioners.
- 3. Working knowledge of county operations.
- 4. The ability and time to respond to requests for information from ACCG policy staff in a timely manner.
- 5. Authority within the county government structure to request and receive timely responses to requests for information.
- 6. Knowledge of the various departments within the county and the points of contact within each to obtain information and feedback.
- 7. Ability to provide periodic reports to the members of the board of commissioners and other county officials regarding the legislative reports and activities of ACCG.
