# RESOLUTION NO. 18-10 09

A RESOLUTION FIXING AND PUBLISHING QUALIFICATION FEES FOR OFFICES SUBJECT TO ELECTION IN THE YEAR 2018; REPEALING ALL ORDINANCES IN CONFLICT HEREWITH; AND FOR OTHER PURPOSES.

WHEREAS, O.C.G.A. ' 21-2-131(a)(1) provides the governing authority of any county or municipality, not later than February 1 of any year in which a general primary, nonpartisan, or general election is to be held, shall fix and publish a qualifying fee for each office to be filled in the upcoming primary or election; and

WHEREAS, the Stewart County Board of Commissioners, in addition to complying with this code section, intends to adequately notify the citizens of the County in order to encourage public participation in the electoral process;

NOW, THEREFORE, BE IT RESOLVED by the Stewart County Board of Commissioners as follows:

District 2 and District 4 positions on the Stewart County Board of Commissioners are subject to election in 2018 to be held on the Tuesday next following the first Monday in November. The qualification fee for a position on the County Commission shall be \$108.00 and must be paid at the time a candidate qualifies.

District 2 and District 3 positions on the Stewart County Board of Education Section 2. are subject to election in 2018 to be held on May 22, 2018. The qualification fee for a position on the Board of Education shall be \$75.00 and must be paid at the time a candidate qualifies.

The County Clerk shall publish in the legal organ for Stewart County the ad Section 3. attached hereto as Exhibit A.

Section 4. All resolutions or parts of resolutions in conflict herewith are repealed.
