RESOLUTION NO. 2018-0710

A RESOLUTION OF THE STEWART COUNTY BOARD OF COMMISSIONERS TO APPOINTMENT MEMBERS TO THE STEWART COUNTY WATER AUTHORITY FOR THE 2018-2021 TERM

WHEREAS, Article III, Division 3 of the Code of Stewart County, Georgia, as amended, provides for the Stewart County Water and Sewage Authority; and

WHEREAS, under Section 2 of Division 3 of Article III of the Code of Stewart County, the authority is comprised of five members, one appointed by the governing authority of the City of Richland, one appointed by the governing authority of the City of Lumpkin, and the remaining three members appointed by the governing authority of Stewart County; and

WHEREAS, members of the Stewart County Water Authority serve for terms of three years, beginning on July 1 and running through June 30 of the year of expiration and until their successors are appointed and qualified; and

WHEREAS, the terms of the members of the Stewart County Water Authority are staggered so that the current term of members appointed by the Cities began in 2017, the current term for one member appointed by the County (the former City of Omaha appointment) began in 2016, and the current term of the other members appointed by the County begins in 2018; and

WHEREAS, the current members whose terms expire in 2018 are County-appointed members John B. Richardson and Marcus Taylor;

NOW, THEREFORE, BE IT RESOLVED by the governing authority of Stewart County, Georgia, the Stewart County Board of Commissioners, as follows:

1) The following persons are appointed to serve as members of the Stewart County Water Authority for the three-year term which began on July 1, 2018, effective immediately:

Charlie Waful Mitzy Lynch

2) All other Ordinances and Resolutions of Stewart County, Georgia in conflict with this Resolution or governing its subject matter are hereby repealed.
