The Stewart County Commission held a regular meeting on December 10, 2019. The meeting convened at 4:30PM at the Stewart County Courthouse with Chairman Joseph B. Williams presiding.

## Reading and Approval of Minutes

Commissioner Joe Lee Williams moved to approve all minutes for November 2019 meetings and seconded by Vice Chair Arcola Scott. All were in favor and motion carried.

#### Reports

A. County Manager's Report - Reviewed and Discussed.

#### Old Business

- A. <u>SQHS Building</u> Ongoing Process Lawyer will generate contract for building usage.
- B. 2020 Expenditure and Income Budget Vice Chair Arcola Scott moved to approved 2020 Expenditure and Income Budget for \$4,614,543.82 and seconded by Commissioner Tyrone Nelson. All were in favor and motion carried.
- C. <u>2019 Budget Line Adjustments</u> Vice Chair Arcola Scott moved to approve the resolution of the Stewart County Board of Commissioners to amend the budget adopted for the fiscal year beginning January 1, 2019 and ending December 31, 2019 and seconded by Commissioner Joe Lee Williams. All were in favor and motion carried.
- D. <u>2019 Income Budget</u> Vice Chair Arcola Scott moved to approve the resolution of the Stewart County Board of Commissioners providing for a budget for the fiscal year beginning January 1, 2020 and repealing all resolutions in conflict with this resolution and seconded by Commissioner Tyrone Nelson. All were in favor and motion carried.
- E. <u>EMS Building</u> In Progress/Ongoing
- F. <u>Dumpster Diving Ordinance</u> During the November 12, 2019 workshop Attorney Minter shared *Article II. Waste Management and Litter Control* sec.30-43. *Prohibited Acts* (7) as stated, "*Scavenging*. No person other than the owner thereof shall disturb or interfere with any container used for the purpose of storing refuse pending its collection, or remove any contents therefrom, or remove such container from its location." This code can be used to address any dumpster diving issues. Therefore, a resolution is not needed because this action is already deemed a misdemeanor.
- G. Survival Flight Will be discussed on agenda in January 2020 meeting.
- H. <u>Fire Engine for EMS Department</u> Commissioner Joe Lee Williams moved to approve the purchase of a new EMS fire engine from Pacolet District Fire Department for \$45,000 from the 2019 Budget and seconded by Commissioner Tyrone Nelson. All were in favor and motion carried.
- I. <u>Revised Personnel Policy</u> Vice Chair Arcola Scott moved to approve the newly revised Personnel Policy and seconded by Commissioner Tyrone Nelson. All were in favor and motion carried.
- J. <u>Contracting Dumpster Pad</u> Commissioner Joe Lee Williams moved to approve the Contract for Dumpster Pad and seconded by Commissioner Tyrone Nelson. All were in favor and motion carried.
- K. <u>QuickBooks</u> Commissioner Joe Lee Williams moved to approve the purchase and use of the QuickBooks Software Program from 2019 going forward and seconded by Commissioner Tyrone Nelson. All were in favor and motion carried.
