- A. **Bid for New Ambulances** – Commissioner Joe Lee Williams moved to accept the bid from Custom Truck & Body Works, Inc. for the purchase of 2 ambulances at a cost of \$271,012.00 each; seconded by Commissioner Tom Mayo. All voted in favor and motion carried.
- B. **Environmental Facilities Agreement – Water Authority** – Commissioner Joe Lee Williams moved to table topic until later date; seconded by Commissioner Tom Mayo. All voted in favor and motion carried.
- C. **TIA Hospital Road Resolution** – Vice Chair Arcola Scott moved to approve the TIA Hospital Road Resolution; seconded by Commissioner Joe Lee Williams. All voted in favor and motion carried.
- D. **Intergovernmental Agreement with Webster County for Hospital Road, Miller Road, and Sundown Road** - Vice Chair Arcola Scott moved to approve the Intergovernmental

Agreement for road work to be performed in Stewart and Webster Counties; seconded by Commissioner Joe Lee Williams. All voted in favor and motion carried.

**New Business:** 2024 Budget. Discussion during called meeting immediately following.


