Commissioner Joe Lee Williams left the meeting at 5:55

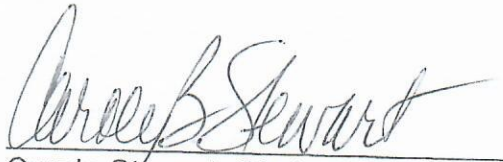
Commissioners' Comments –

Commissioner Tom Mayo – none

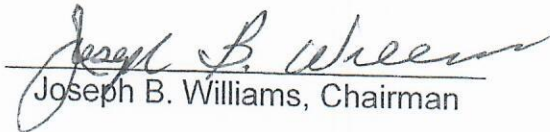
Vice-Chair Arcola Scott – inquired of Road Superintendent if they were receiving lots of trees and limbs at Road Department especially from the city
